### **Dear Members**

The Executive Committee is pleased to present this Annual Report for Queensland Private Enterprise Centre Inc (QPEC) for the year ending 31 December 2023.

# **EXECUTIVE COMMITTEE**

During the year the following changes occurred on the Executive Committee:

- Mrs Debbie Perrett was re-elected to the committee at QPEC's Annual General Meeting held in June 2023
- Ms Franki Ganter was re-elected to the committee at QPEC's Annual General Meeting held in June 2023.
- Mr Chris Skelton was re-elected as Secretary at QPEC's Annual General Meeting held in June 2023.
- Ms Susan Rix retired as President of QPEC at the end of the Annual General Meeting held in June 2023. Ms Franki Ganter was elected as Acting President of QPEC at the same Annual General Meeting until a replacement candidate is identified for the position. The Executive Committee is in the process of identifying an appropriate candidate to put forward to members for appointment to the position.

### **ECOMAN OPERATION REVIEW**

During the 2023 year, 18 programs were delivered (to students from 35 schools) including two new programs at Townsville and Cairns. This is an increase of 3 programs on the total number of 15 programs delivered in 2022. Not only is it very rewarding to be able to deliver the ECOMAN program in regional areas but it is very pleasing to see QPEC extend its reach to these regional areas in Queensland. This is due to the dedicated efforts of our Education Coordinator, Debbie Perrett, and program facilitators. The Executive Committee extends its thanks to them for their continuing commitment to delivering the program.

The Brisbane Girls' Grammar School (BGGS) students again participated in the ECOMAN Program in 2023. It involved running 8 simultaneous programs at the school for approximately 170 students. The program ran over a number of weeks (one and/or two days per week) in July/August with the BGGS teachers involved in delivering parts of the program normally delivered by the facilitators. Unfortunately the program was not as successful as in previous years due to a number of issues encountered by the school during the delivery of the program, which were beyond the control of the school and QPEC. Unfortunately, these factors impacted on the student experience of the program. As a consequence, BGGS has made the decision not to deliver the program in this way in 2024 but will still be involved in the combined two day program with Brisbane Grammar School. A huge thank you to Bob Kelsey for the work he did in processing the results for classes – which proved to be a challenging exercise given the circumstances which presented during the course of the program.

The relationships that develop between QPEC and schools particularly between our Education Coordinator and facilitators and the school Heads of Department underlies the fact that many schools each year send their Year 10 and 11 students to experience the ECOMAN program year after year. These teachers do this because they see the practical benefits of the ECOMAN program in further explaining commercial and business concepts and realities to students.

Feedback from students and teachers after they have completed the program underline the reason why the program is so successful and valued by the students and teachers.

# SPONSORSHIP AND OTHER SUPPORT

Funds from The Sylvia and Charles Viertel Charitable Foundation continued in 2023 to support the delivery of the ECOMAN program to students. The Foundation has supported ECOMAN programs since 2009 and the Executive Committee thanks them for their valued support. This funding has come to a natural end and alternative ways of funding the work of QPEC is being sought.

Mid-City Rotary Club again sponsored the Yeronga State High School program and the committee thanks them for their ongoing support. Mid City Rotary Club ceased operating in 2023 and made a donation of \$6000, as part of the distribution of funds upon cessation, to support the delivery of the ECOMAN program to Yeronga State High School for another two years.

QPEC also wishes to thank Findex (Townsville), Ultons (Bundaberg) and the Business Liasion Association together with BDO and Grant Thornton (Cairns) for sponsoring the regional programs.

Our venue sponsors provide their CBD board rooms and meeting rooms where the

programs are delivered. They too deserve our thanks once again. Two venues provided their facilities on more than one occasion: CA ANZ and Grant Thornton, to whom we owe a special thanks. The other venues QPEC wish to thank are: CPA, Moore Australia, Ultons (Bundaberg), BDO, Findex Townsville and James Cook University, City Campus.

These venues play an important part in the ECOMAN experience for the students, where for two or three days the students become directors of a fictional company and make decisions that will impact on the business of their company. They also enjoy the 'vibe' of being part of a big city office.

Sponsors are critical to the on-going viability of the Ecoman programs. Currently programs in Brisbane cost a little over \$1,000 per day to run (on average) and overheads are about \$24,000 per year. Many schools find \$1300 per day (two day program) or \$1950 (three day program) too big an ask and adding further on top of that to cover overheads would mean we would have less schools to spread the overhead across. While QPEC has sufficient funds to continue operating in the short term, the Executive Committee, has been considering ways of ensuring the sustainability of the program over the medium to longer term. Already, Stuart has submitted several proposals for future funding partnerships and we look forward to reporting to members on the progress of those proposals over the balance of this year.

The Executive Committee is delighted to have Stuart on board and wishes to thank him for his efforts to date in helping to not only secure the current financial position of QPEC but also lay the groundwork for our future growth.
